- Every dog over 3 months of age (other than those exempt pursuant to section 33 of the Act) must be registered.
- Payment of the relevant registration fee and any fee for the late payment of the registration fee must accompany this application.
- Registration remains in force until 30 June next and may be renewed for further periods of 12 months.
- The Registrar may refuse to register a dog if satisfied that the dog is kept in a kennel for a purpose in connection with a business that should, in the opinion of the Registrar, be registered under section 35 of the Act.
- The information sought in this form which has been marked with an * is a mandatory field. Information kept in the register, Dogs and Cats Online, may be available for public inspection upon application, in accordance with the South Australian Information Privacy Principles.
